| 5.  | Guest Speaker                             | John Knaggs, CEO Sun Central Maroochydore Australian first pneumatic rubbish system to take rubbish from the city centre to a processing centre. Light poles will serve many functions – lighting, wifi, traffic flow sensors and other activities.  Maximum 25 stories however the hotel site will not have a limitation (save for the airport restrictions). The company website will upload all of this information this week.  www.maroochydore-city.com.au. Sunshine Plaza will continue and grow and there is an announcement soon as to their \$320m expansion where the carpark is currently located and includes David Jones. It has all been approved and an announcement is imminent by the Sunshine Plaza. Funds spent by Council on the horizontal part of the site will need to be recouped into the local project fund by sale of land for development of the vertical part of the site. What is the 5 year target? Bulk excavation of stage 1 is occurring now. The civil part of the site will be constructed and by late 2018 buildings should be coming out of the ground in stage 1. The company is focusing on the demand for these tenancies and will be approaching tenants rather than developers. |  |

| 12. Airport Update          | Ken Vaughn. Still awaiting Federal Government approval on matters of national environmental significance. Most of it is around the building of the runway and the additional heights (tower and so on). Sarah will inform you via the newsletter of a council release. 2,450 metre x 45 metre runway with expanded facilities, they are aiming for more flights across Australia, Asia and the Western Pacific.  Our airport is growing at 24%, higher than the Gold Coast at second with 12.5%.  Over 960,000 passengers this year which will increase further with Jetstar introducing flights to Adelaide.  Tony Freeman and Ken attend meetings on behalf of TWRA with the next one being on the 5 <sup>th</sup> July. At the moment Peter Pallot has not released the recommendation as he is waiting to release that directly to Council. Looking to be the end of 2020 now for the works to be complete.   |  |

# **COUNCILLOR UPDATE** TWIN WATERS RESIDENT'S ASSOCIATION MEETING 13 JUNE 2016

Unfortunately I am unable to attend tonight's meeting due to another commitment, so please accept my apologies.

I'm happy to provide this update to be read out at the meeting.

#### Airport EIS

The Queensland State Coordinator General's report delivered on 19 May 2016 has approved the Environmental Impact Statement (EIS) for the Sunshine Coast Airport Expansion Project and confirms the project will deliver major economic and social benefits to the region.

Any adverse environmental impacts can be acceptably avoided, minimised, mitigated or offset through the implementation of the measures and proponent commitments outlined in the EIS documentation.

The Commonwealth Government will now review the report and provide response within 30 days of the report being received. Council will consider the conditions and recommendations contained within the Coordinator General's report. It is envisaged the new runway will be open and operating in 2020.

#### Parks, Equipment & Gardens

I'm really happy with the level of service being provided around Twin Waters, and I hope that locals are too. I'm proud of the work being carried out by Council officers and contractors - I think that they are doing a great job.

#### Mudjimba Surf Life Saving Club

The Mudjimba Surf Life Saving Club are currently planning to expand their clubhouse. The club has applied to the State Department of Natural Resources and Mines to increase the size of their lease area. The Club's president, Michael Hughes, would like to see the facility used by the community to provide a source of income for the Club.

Once the expansion of their footprint is confirmed, the Club intend to have lots of conversations with members and the local community on what they want, prior to commencing the design phase of the project.



# **Parking**

Parking of cars, boats, caravans and trailers in residential streets continues to be an issue. I have recently attended a number of onsite meetings with a few local residents and Council's traffic engineers. I am continuing to work with Council officers to find solutions to the issue and will keep the association updated.

### Noojor Road Boat Ramp & Car Park

You may remember me mentioning the terrific new two lane boat ramp and car park that was under construction at Nojoor Road and due for completion around October this year. We're on track to blow that initial completion date right out of the water! The project is on course for completion by the end of July – a fantastic outcome for all of our local recreational boaties. Along with the two-lane boat ramp this upgrade also includes a floating walkway, a new bitumen car park with 54 spaces and connecting pathways.

It's a major improvement on the previous gravel entry point that had limited parking. Council undertook this project after conducting a study of our recreational boating facilities and it's sure to make it easier and safer for people to launch their boats into our beautiful Maroochy River.

## Solar Farm

Council's quest to become Australia's first local government to offset its entire electricity consumption from green energy is powering ahead. Construction of the 15 megawatt (MW) solar farm has kicked off - Downer was awarded the tender to construct it.

The project will deliver \$71 million worth of benefits, less the cost of \$49 million leaving savings of \$22 million. The financial benefits that have been estimated are quite conservative particularly the large scale generation certificates (\$22.6 million) which could be more than 50% higher.
