

## Thanks for attending general meeting

A TWRA general meeting was held on Monday evening, 11 February at Novotel Resort. The meeting was very well attended by about 130 residents. Our Guest speaker was Ross Ullman, the Project Director Sunshine Coast Airport Expansion Project . He presented an overview of some unique challenges associated with this important airport project, including the key features:

• New 2,450m long by 45m wide east-west runway, capable of servicing aircraft such as the A350, B787 and B777

• Two end taxiway loops, navigation aids and expansion of the existing apron and terminal

• Dredging sand for fill from mooring of a dredge offshore at Marcoola and sand pumping to the project site (completed and now being spread into position)

• Environmental offsets – significant drainage and landscaping In response to a question, Ross said that the bund on the northern side of the new runway was being extended and strengthened and that it would divert water from the northern side via channels to the Maroochy River. There would be a net benefit for all communities south of the new runway.

Thank you to Jason O'Pray, Divisional Councillor for attending the meeting. He reported on local infrastructure developments, including the completion of a new car park by the North Shore Community Centre and sporting fields. Jason recommended that we get involved, inspired and connected with the Centre. Details are on their website at:

http://northshorecommunitycentre.org/ Viewing decks have been completed at Marcoola and Mudjimba beaches and now another is under construction at Twin Waters beach, near the lifeguard headquarters. Jason reminded us that the Twin Waters beach is patrolled every day from 8.00 am to 5.00 pm.

Cr O'Pray also reminded us that tourism is an important part of the local economy. He believes there has been a record number of visitors over the Christmas New Year period but there was also some road congestion.

Jason was asked about removal of rubbish over the holiday period at Nojoor Road and Mudjimba Beach – He said complaints were usually handled within 24 hours by Council. There was some discussion on the need for additional bins.

The TWRA intends to monitor this as it affects the appearance of our area as well as having environmental consequences if the bins are allowed to overflow.

Our local member, Fiona Simpson MP was unable to attend, but provided a report. She said she is committed to working with community and fighting for the infrastructure, services and actions that will get that balance right. Fiona expressed concern about public transport and she believes the system needs fixing. She wants better bus services to support the Sunshine Coast's growing population, stronger action to tackle fare evasion and safety issues.

However, Cr Jason O'Pray commented "if we don't use it, we may lose it."

#### Stockland Lodges Development Application

As reported last month, Stockland has submitted their Development Application for Twin Waters West.

There is a process to be followed that is set out in the State Planning Act. Two phases are currently in process - the Referral phase and the Information Request phase. Both are Council's responsibility to manage. The Council must Refer relevant parts of the DA to other agencies, such as State departments like Environment, Waters, Main Roads etc. as well as independent agencies such as Unity Water, Energex and so on to get formal review and sign-offs from these agencies. Council must also review the DA for completeness and any queries and make a formal Information Request back to Stockland for supplementary information etc.

The IR was lodged with Stockland at the end of January. Stockland has up to three months to respond. Then Council must consider all the information and responses before proceeding to the next phase which is Public Notification when the public will have the opportunity to review and make its comments about the DA. The final phase is the Decision, which Council can make only after all the previous phases have been completed and considered. Given the processes involved, it would appear that the Public Notification phase could occur around mid-year. At this stage, no specific dates are set.

The TWRA Sub-Committee is continuing to review the DA and we are planning to meet with Stockland to seek clarification and information on some matters. We will also review any additional information that becomes available as part of the IR process. Our objective is to form a view about whether the proposed development will be "equal to or better than the existing Twin Waters". This is still a work-in-progress and will be so until all relevant information is in the public domain. We will continue to keep our community informed. The full DA and supplementary information is on the Council's web site.


