Why not to do your own legal work

Why would you spend hundreds of dollars having a lawyer write up a document that you are more than capable of writing up yourself?



In some cases, there may be no adverse consequences of a person producing their own legal documents. Unfortunately, those cases are the minority. Here are some examples of things that can go wrong.

• The Post Office Will Kit. The Will kit is a great product. It's unfortunate that the words added by the will-maker can have completely unintended results. Take for instance the woman who leaves "1 Smith Street, Smithsville to my daughter" and the "rest and residue to my son." Mum thought that the "rest and residue" would be some second hand furniture and cash in the bank of around \$10,000. Unfortunately, the home had to be sold when Mum went into care. She was unable to make a new Will due to loss of capacity. The gift of the house to the daughter failed because the home was no longer owned by Mum. The way Mum had worded her will meant that the "rest and residue" (including the sale proceeds from the house) went to the son. This left a huge mess for the daughter to try to mop up after Mum passed away.

 The Contract to Sell Real Estate. A centleman sells his investment home to his tenant without the help of a real estate agent. The gent retrieves from his file a Contract document from when he purchased the property back in 1994, and uses it as a basis for the new contract. Taking comfort in the thought he now has an unconditional contract to sell his investment, he signs a contract on another property. The tenant cancels the first contract on technical grounds because the requirements of the Property Occupations Act 2014 have not been met in drafting the new Contract. He now has no funds to complete the second purchase in time.

• DIY Conveyancing. A seller decides that there's nothing to Conveyancing, so they'll look after their own legals. They arrive at settlement and discover there's a mortgage registered over their Title Deed even though they paid the bank the loan back over 10 years ago. Settlement doesn't occur, the Buyer cancels the contract and the Seller's back to the drawing board with the sale of their home.

 Google School of Law. Google is brilliant provided you know what you're searching for. A person signed a contract to buy a business in his own name "and/or nominee" and later tried to nominate his new Company to be the buyer. In Queensland, this can result in double stamp duty payable on the transfer to him and then to his company. He had searched the stamp duty rules in another jurisdiction not realising it was a State based tax, with special rules applying in Queensland in relation to nominees.

In many cases it is uneconomic and inefficient to try to do your own legal work. Often your solicitor can help you for a fraction of what it will cost you if you get it wrong. One of the most common problems with servicing pools, and yet so easy to fix, is the level of water in the pool. Water levels are crucial, especially in the Rurg Pool Services summer months when we have very hot sunny days, and evaporation of the pool water is at its highest.

Properties that back onto water have a more rapid loss of pool water level, not only from evaporation but also with the wind that comes off the river or canal. If the water level gets too low, a vortex can be created in the skimmer box that can send air into the pool pump and system. Air in the system can escalate to poor water flow through the system and ultimately a burn out of the pump due to overheating.

A costly exercise that can be easily avoided. You should check the water levels at least a couple of times a week. To have the water level approximately three-guarters of the way up the skimmer box is ideal at all times.

Once the water starts creeping below half way down the skimmer box that's when it can escalate into a much bigger problem.

We live in a great place. A while back we received an email from Caitlin, a local 12 year old who wondered if TWRA could provide a netball post and hoop so she, her friends and other young netballers could practice ... the nearest hoop was on the other side of the river.

We sent her request on to Councillor Jason O'Pray who organised an inspection of the Moorings Circuit park with other Council officers to evaluate the park. Most important was availability of space in relation to children's safety. Could the post and hoop be positioned in such a way which minimised a loose ball going onto the road? They all agreed it was possible and could be achieved in a short period of time. The final location near the swings and other play equipment meant any parent could see children of different ages using the range of equipment. It was also positioned away from the street - even if it were a very quiet street, kids chasing a loose ball and any car do not mix well!

We were delighted to see that the pole was erected and a few days later the netball hoop positioned. This makes it a great area - a girl's request was passed to Councillor O'Pray and he worked with others in Council to solve a problem and provide a netball hoop for Caitlin and others to use and practice. A simple request turned to a reality.

We put pressure on Council when it's needed, and we also recognise their response when it's deserved. Over the last six months, we complained to Council about:

. The bins and rubbish at the new boat

ramp in Nojoor Rd ... they added bins and collection services.

 The intersection of Ocean Drive and Nojoor Rd as a dangerous intersection ... they were able to arrange improved road marking and signs and used Federal Government "Black Spot" funds to improve safety

• The sudden early growth of bindii in many park areas... they were able to arrange additional spray to minimise the growth before summer

 Trees and branches overhanging some footpaths... they responded with some additional pruning and improved landscaping

We also discuss with Council the landscaping and maintenance and they are currently planning how some of the long-term parks and gardens can be refurbished to maintain the look and feel we have loved in Twin Waters. Until next month,

Sunshine Coast

SC Airport development and Master Plan New Runway

 The current North South runway, 18/36 will be decommissioned to allow the construction of the new runway 13/31. This is expected to occur in May 2020.

• The SCC has confirmed that the southern portion of the existing runway (around 1000M) will be repurposed as a Taxiway providing access to the southern apron

• Runway 18/36 cannot be maintained due to inability to meet CASA Aviation Safety standards.

· A new flood mitigation levee is being

constructed and this will be a permanent and reliable levee replacing the existing earthen mound which has slumped, eroded and not reliable.

New Financial Year Resolutions
