President's Report

February was a significant time in our major campaign to restore and properly maintain the many footpaths around Twin Waters.

The TWRA met again with Sunshine Council for a number of critical site inspections of the deteriorating footpath network.

The site inspections with Division 8 Councillor, Jason O'Pray and Council engineering staff, were to confirm the best form of long-term repairs.

Over the years, various patch-up jobs have been tried as the original designs wore out. Happily, the inspections confirmed a uniform approach has now been agreed that is both more presentable and will last for decades. As reported in last month's newsletter, this is the last step in a good communication process with Council over the last few months; in particular resulting in Council's commitment to a significant footpath repair program over the next 5 years. The upgrade plans being finalised through Council's Budget process each financial year. The result is especially supportive when its remembered that Twin Waters has about 1% of the footpaths in the Council area but will be using about 10% of allocated funds for each of the coming years.

Finally, a comment about the recent heavy rains. Our 'Life on the Lake' Segment on Page 2 of this edition - and daily Facebook posts — captured the soggy moments. But can I remind readers that following the downpour, there is a menace beneath the surface: bull sharks love the muddy water!

See the pic on the right to make it more real! I've noticed teenage boys continue jumping from the bridges with apparent lack of care for what might be in the muddy water.

We have often seen the sharks chase fish up the canal then turn them so the fish slam into the revetment wall. The sharks then feed on the stunned fish! In dirty or muddy water the sharks have been more visibly active.

Life on the Lake...Everything damp except Twin Waters spirits!



But by the weekend, cabin fever was driving 'Twin Waterers' out to run between the rain drops - and dogs won't walk themselves.

Between Wednesday 23 February and Sunday 27th, local rain gauges ran out of space - as more than 650 millimetres drenched the district. If you're old school - 25.5 inches.








The Bureau of Meteorology station of Picnic Point marked the high point of the Maroochy River as Sunday, 6.15 am - up 1.61 metres! After which, thankfully, it started to come down.

However, the lake performed well. While it overflowed the normal shoreline and the top of revetment walls, it was nowhere near housing. All building blocks are located above flood levels. Twin Waters has never had any river or localised overland flooding enter homes here.

The weekend was wet enough, but on the Friday night before water flooded the Ocean Drive entry to David Low Way. The result – some end of week mayhem for a bit. Despite the inconvience, the water was gone in the morning.



The next day, Twin Waters shops were open, but residents had to brave the water into Magnolia Avenue.

Again, it drained away over the next day.



Despite the downpours, long term Twin Waters residents are adamant that despite pics like the one below on the left, taken half-way along Twin Waters Drive – that the floods of February 1999 were worse!

Then water extended all the way up to the roadway. Sadly, we've not been able to find any photos.



TWRA General Meeting – 14 February.... At Novotel Sunshine Coast Resort

Every two months TWRA holds a General Meeting at Novotel to inform residents. You are always invited, member or not. State Member for Maroochydore, Fiona Simpson addressed the well-attended February meeting. Fiona advised that she is asking the State Transport Minister for extra support to combat an outbreak of 'hooning' in Mooloolaba and Maroochydore. Twin Waters West

An update on Twin Waters West Appeal by Stockland over Sunshine Coast Council's refusal of their Development Application. The next hearing in the Planning and Environment Court is scheduled for 10 March. In December, the Council had sought a hearing to modify its reasons for refusal. Then at the hearing held in February, the Court set a timetable for the parties to resolve an "Agreed List of Issues" before the next hearing on 10 March.

Looking After Our Parks

Max Mills gave a report on the work of the Maintenance Group, (a sub-committee of the TWRA) that works with the Council to oversee the upkeep of Twin Waters 66 parks. Twin Waters residents pay a small levy as part of their rates for extra work to keep the local public areas to a high standard. The levy is held in separate trust fund. Airport Business

In news, from the Airport Forum, Kevin Lyons told the meeting 110,000 people passed through Sunshine Coast Airport in the previous month, although it will take two years to return to pre-Covid levels. February also saw the Sunshine Coast Airport share in a \$200 million funding boost from the State Government to promote regional airports. The Passenger Terminal is expected to double in size over the next 5 to 7 years.

Shorebirds

Footpaths - there is a plan!

When Lend Lease designed the original Twin Waters community, the plans included many new and innovative concepts – including the footpaths, many with hardwood timber inserts. The sandy soil and our weather meant that the timber bands tended to deteriorate over time.

Once the Twin Waters community was established, the public areas were all handed over to (then) Maroochy Shire Council and absorbed into the more recently merged Sunshine Coast Regional Council and that meant Council managed repairs and maintenance of these assets.

As we all know, footpaths can move over time and timber bands show signs of wear. Council has tried to maintain footpaths and trialled many different materials with varying degrees of success.

Material used to repair footpaths included replacement timbers, black and coloured bitumen, paver inserts, concrete (plain and painted) and concrete "sleepers".

Some examples:





Some of the original footpaths were made from decorative paving bricks.





And then there was the bitumen paths on Ocean Drive near the golf course and Prestwick Drive.

Following meetings with Cr Jason O'Pray and representatives from Council, we have been given draft plans that will upgrade priority footpath problems during the next few years.

After 25 years some of the timbers are showing more serious areas of decay







Footpaths Continued

The first of the planned upgrades will be the footpath alongside the golf course on Ocean Drive between Tralee Place and Twin Waters Drive roundabout. This was scheduled to start back in November 2020, but the surveyor team discovered an alignment issue with the footpath which required some time-consuming problem solving.

Because the paths with timber bands are a series of small slabs and not "tied" together, they are subject to ground movement and replacing the timber inserts is not as simple as it would appear from both an aesthetic and safety view. Timber panels have to be removed, often the slabs have to be trimmed, the undersoil removed and replaced with road base type material and compacted to ensure stability.

Then new replacement components inserted with finishing to a required safety level. This is why "temporary" solutions such as bitumen have often been used.

Where longer sections of path have to be replaced it is faster and more economical to completely remove the existing path, prepare the base, position the formwork and reinsert and finish new concrete with a broom finish. New white concrete pathways then have a life expectancy of 80-100 years and in most cases be maintenance free.

Of course, Council will continue to provide interim repair solutions in other areas particularly where a safety issue is identified.
