Updates from Twra General Meeting on 8 April.

(TWRA General Meetings are open to the public and usually held on the first Monday every second month. Location: Novotel Sunshine Coast Resort at 7.30pm. Next meeting: Monday 3 June.)


Stockland Briefing On Next Steps for Twin Waters West.

Stockland Project Director, Josh Sondergeld made the first in a planned number of appearances to keep the community informed following the preliminary approval by the Sunshine Coast Council late last year. The overriding message was that events will move slowly over the next few years.

He also noted that even though the project had Council approval, it must also seek environmental approval from the Federal Government. Stockland will engage with the local community as it progresses through this. Future TWRA newsletters will report details once they are available.

At the same time, planning is set to begin on the proposed changes to the intersection from Ocean Drive to the David Low Way - the main entry point to the development. Done in consultation with the State Government, this will take up to 20 months, with actual work not expected to start until late 2025. Construction work when it begins, will access the site via Godfreys Avenue, down near the Maroochy Bridge.

It is expected to be several years before the first lots are available. The overall project will take between 5 to 7 years, depending how fast the completed lots sell.





Security Concerns:

As Sophie mentioned in her President's Report, the audience at the General Meeting spontaneously raised their growing concern about the increasing crime rate in Twin Waters over the last 6 months. For instance, in March, the TWRA Facebook showed a video caught by a home security camera of youths trawling the neighbourhood after midnight looking for opportunities to steal cars. At the meeting, Member for Maroochydore, Fiona Simpson offered to liaise with the Police to stage a community forum to further spread knowledge of practical counter measures. Discussions are also now underway with Neighbourhood Watch to organise the event that is planned for June. Further details in coming weeks.

Rates Unlikely to Jump Because of Land Values Increase:

As Sophie also noted in her report, both Fiona Simpson and new Division 8 Councillor, Taylor Bunnag acknowledged the big rise in official land values recently issued by the State Government. Taylor noted that values had increased by an AVERAGE of as much as 36% across the Sunshine Coast, although individual residents had seen jumps of close to 50%. However, he noted that in the past increased land valuations did not automatically translate to the same rise in rates. In later comments to the TWRA, Taylor said the Council had 49 different categories of rates - and that land value was just one of many metrics used to determine the final result. The Sunshine Coast Council raises over \$300-million a year from rates, but the final position would not be known until after the formal budget review process in July. In the meantime, as the new Councillor, he remained committed to closely monitoring service delivery to all Division 8 residents. Taylor will provide an update at the next TWRA General Meeting at Novotel Sunshine Coast Resort on Monday 3 June.

Twin Waters Golf Club - Happy to be Fenced In:

Taylor also addressed the latest talking point in the local coffee shops - that new fence around the Twin Waters Golf Club parking lot. For those who asked whether the Club could do that, Taylor's answer was that the right to fence in was covered by the original planning approval going back to the 1980s. In recent years, the Club has been frustrated by the number of non-Club members using their parking lot that sits beside the Twin Waters shops - where parking is often squeezed at peak times. For those who don't like the 'compound-style', the Club asks for patience. They plan to soften the look with plants around the edges.

Police Now Watching Scooters!

While we fixate on the local crime wave Neighbourhood Watch warns that Police are cracking down on the electric scooters that seem to be everywhere from the middle of the road to footpaths and narrow bridges. They suggest it's a good time to remember the rules - as it could cost if you're caught.

A rider MUST be 16+ to operate, or 12-15 years old with adult supervision.

Helmets are required, which will be a shock to some. Bike owners can ride on local paths and bike lanes and streets - but the speeds vary. Maximum speed is 12 km/hr on footpaths OR 25km/hr elsewhere.

No doubling is allowed. (Sure! See photo!)

By the way, that's a Fat Bike – the next generation that comes after electric scooters. Big tyres and an electric motor. Almost a motor bike.

You can ride your E Scooter/Electric Skateboard on footpaths, shared paths, separated paths and bike paths. Local streets (speed limit of 50km/h or less, no dividing centre line) On-road bike lanes (where the road speed limit is 50km/h or less, or where the lane is physically separated from the road).

Maintenance Report - Baywater Drive Moves ahead - new trees planted!

The Council contractors have planted 9 small flowering native trees in Baywater Drive as part of the rejuvenation process. The trees are each about 1 metre high and flower in late summer and autumn. As we reported in April, the Lemon Myrtle, lvory Curl and Yellow Poinciana will provide quite a spectacle in Baywater Drive. Starting in May, the Contractors will be adding mulch to all Twin Waters garden areas where required Because of the recent rain, the grass and weeds have caused some issues. The Contractors will have extra people to catch up.



The first paths to be replaced included Ocean Drive alongside the golf course; Esperance Drive and Lake View Drive around Warwick Daniels

Park. (First Picture)

In other areas not listed above, we are working with Council to have the timber inserts that are particularly rotten and potential tripping hazards to be replaced with poured concrete.

Next Steps On Footpath Replacement Program:

We have now been advised that the footpath from Ocean Drive to the Wattlebird Bridge will be replaced during 2024-2025 and Wattlebird south from the bridge to Brushbox Circuit will be replaced during the 2025-2026 financial year.

Council has also advised that they expect to replace other footpaths in Waterside, Sunview, Twin Waters Drive Park and Twin Waters Drive in the financial years 2026-27 through to 2030-2031.

Two years ago we met with Council to discuss replacement of some footpaths in Twin Waters as they had deteriorated. The outcome of that meeting was a plan to install brushed concrete footpaths in the coming years. Council advises this type of footpath is cheaper and provides a better outcome for the paths that need to be removed and replaced. The new footpaths are expected to be adequate for the next 100 years!
