### Rates And Roads The Main Topics At Twra General Meeting at Novotel Sunshine Coast Resort

Apart from the formalities of the Annual General Meeting and the change-over in TWRA personnel, Division 8 Councillor Taylor Bunnag briefed the gathering on the formula Council used to limit rate increases following the average 36% increase in land valuations across the Sunshine Coast Council area.





Council had kept increases to 5% - and then increased the range of qualifying properties from - \$420,000 to \$650,000 to \$560,000 to \$850,000. Rates for properties valued over \$850,000 were increased by 10%. For instance, Marcoola's unimproved land value had gone up between 50-60%. The 10% increase would also apply to Air B &B properties – as Council wanted to encourage long term rentals to help with the housing crisis.



### Motorists Frustration Recognised With Improved Access To David Low Way From Mudjimba

At the same meeting, Member for Maroochydore, Fiona Simpson advised that the minor bottle neck entrance from Mudjimba Esplanade to David Low Way would be improved this financial year with the addition of a right-hand turning lane for a safer slip way.

#### Maintenance Update July/august

The TWRA Maintenance Sub-Committee reported that contractor, The Plant Management Company had brought on extra staff to catch-up on necessary work. Mulching is being done where needed. Winter weed spraying conducted to eradicate broadleaf Bindii growth. The Sub Committee has submitted an analysis of the public garden areas to Council with suggestions for a refurbishing program. The Committee is also waiting on Council advice on the best type of small flowering shrubs to add color to local gardens and a suggested timetable







Discussions have also begun about the refurbishment of the entry signs into Twin Waters and its sub-zones with names like The Landings and The Shores.

Last repainted 9 years ago, and part of the original Lendlease design that established the community, they now show signs of wear, tear, cracks and pealing on the metal signs. At present they receive modest maintenance, but the time is coming for a major re-think. More in the coming months.



#### **Crime Continues Down In Twin Waters – But Still Here.**

The downward trend of Twin Waters crime reported in July continued in early to mid-August with NHW first suggesting they had nothing to report for the newsletter – and then...on 17th August an unlocked car was stolen from Veerings Crescent – it is thought about 5 am. Rumours later suggested possible culprits who were believed to have tried to gain entry to two nearby houses while the residents were away. NHW speculated that the street may have seemed good pickings with a closed-up look, as other residents were away camping. So, pay attention to locking up, as you never know.

## **Golf Club Liquor Licence Causes Disquiet**

It's the sign that turned heads for residents living near the Twin Waters Golf Club....

The Club had applied to change its liquor licence to allow for 'amplified music'. And as per the rules, notice had to be posted out the front in case the community objects – and it seems quite a few do, especially to the notion that the music could be played 7 nights a week, up till midnight.

A significant section of residents was determined to object before the closing date for submissions on 6th September. Division 8 Councillor, Taylor Bunnag has also told residents that he and the Sunshine Coast Council plan to oppose the application, as well.

For its part, the club is dismayed, claiming that its plans under the new licence are modest, so they can allow background music in the bar and restaurant.

But according to the Office of Liquor and Gaming Regulation at Maroochydore....where the application and objections will be processed, liquor licences are more complicated than just open slather for 'amplified music' 7 days a week. Applicants must pay for an Acoustics Report (cost between \$6,000 - \$10,000) to survey the premises – and consider the proximity of neighbours – as well as the impact of the type of amplified music proposed in the application. The office has a grid reference of expected noise levels ranging from background music in bars, to a single singer with guitar; to duos, to a small band, to a rock band.

## Gardening Competition Update: Judging Set for 12th October.

We have two judges, Glennys Brunn, an experienced and independent horticulturist from Nambour, and Chris Bormann from the TWRA. The judges will have lanyards with their Driving Licence IDs. Prior to 12th October, we will inform entrants of the approx. time their garden will be judged.





There will be four categories this year, three of which are new vs. last year's competition.

- \*1. Best newly created garden (i.e. gardens which have had significant redesign or refurbishment in last 24 months) \*2. Best lawn
- \*3. Best creative pool/patio/courtyard garden encompassing greenery
- \*4. Best street appeal, with focus on colour

We intend the judges will view 24 gardens on the day of judgement, so new for this year, we are asking entrants to provide 2 or 3 photos of their garden so that we can screen down to 24 gardens if we need to. If any entrants cannot submit photos, we will offer to take photos for them.

Thanks largely to Chris Bormann, we have secured even more sponsorship than last year. So, plenty of good prizes! Our sponsors this year are the Sunshine Coast Council, Mitre 10 (Kunda Park), North Shore Tavern, Manawee Nursery, Bunnings (Maroochydore) and IGA (Bli-Bli).

Meet Atiah Bell, who goes by the impressive title -Waste 2 Resource Education Facilitator – for Sunshine Coast Council.


Putting the bins out every week is such a Twin Waters institution we figured we should know how the system works – and is as environmentally friendly as possible.


